ORDINANCE NO. 6 -2025

AN ORDINANCE OF THE TOWNSHIP OF CECIL, WASHINGTON COUNTY, PENNSYLVANIA, AMENDING THE FOLLOWING SECTION OF THE VEHICLES AND TRAFFIC ORDINANCE AS AMENDED: SECTION 226-41, SUBSECTION (D), TO ESTABLISH A PERMIT PARKING AREA ON WILDWOOD DRIVE.

WHEREAS, the Cecil Township Board of Supervisors (“Board”) has the power to protect the health, safety, and welfare of the people and property in Cecil Township (“Township); and

WHEREAS, the Board finds that it is in the best interest of the residents and citizens of the Township to Amend Section 226-41, Subsection (D), of the Vehicles and Traffic Ordinance, as amended; and

WHEREAS, the Township seeks to amend its Vehicles and Traffic Ordinance as set forth herein; and

WHEREAS, the Board has given careful consideration to all public comments and has determined that the adoption of the Amendment is beneficial to the health and welfare of the citizens of the Township.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED and it is hereby ordained and enacted by the Board of Supervisors of the Township of Cecil, Washington County, Pennsylvania, as follows:

SECTION 1. Section 226-41, “Residential parking permit,” Subsection (D), is hereby amended as follows:

D. Designation of residential permit parking areas.

(1) The following are designated as residential permit parking areas:

<u>Area</u>	<u>Bounded By and Including</u>	<u>No. of permits per address</u>	<u>Effective Hours</u>	<u>Permit Fee</u>	<u>Notes</u>
<u>1</u>	<u>Wildwood Drive, from Cowden Road to its terminus, approximately 1000 feet.</u>	<u>2</u>	<u>24 hours per day</u>	<u>\$5.00 one-time fee</u>	<u>Each property on Wildwood Drive shall have two dedicated permit parking spaces</u>

					<u>located on Wildwood Drive, directly in front of each property.</u>

(2) Signs shall be erected along the streets in each residential permit parking area, indicating the days, hours, locations and conditions under which parking shall be by permit only.

SECTION 2. **Repealer.**

Any ordinance, chapter, section, subsection, paragraph, sentence, clause, phrase or portion of any ordinance conflicting with the provisions of this Ordinance is hereby repealed to the extent of such conflict.

SECTION 3. **Severability.**


If any section, subsection, paragraph, sentence, clause, phrase or portion of this Ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portion thereof.

SECTION 4. **Effective Date.**

This Ordinance shall take effect five (5) days after the date of adoption by the Board of Supervisors of Cecil Township, set forth below.
