This notice, under the requirements of Act 14, 97 P.S. § 510-5, is to advise you that Range Resources – Appalachia, LLC intends to submit to the Pennsylvania Department of Environmental Protection (PADEP) for issuance a General Permit 8 for temporary road crossings associated with Oil and Gas Exploration, Production, Processing, or Treatment Operations or Transmission Facilities to be located in Mt Pleasant and Cecil Townships, Washington County, Pennsylvania. A topographic map showing the approximate location of the project site and crossing locations is enclosed.

Also enclosed is a copy of the General Permit Registration for this project. If you wish to submit comments in regard to land use aspects of this project for DEP to consider, you must respond within 30 days from the receipt of this letter to the DEP Permitting and Technical Services Section at **Pennsylvania Department of Environmental Protection, Bureau of Oil and Gas Management, 400 Waterfront Drive, Pittsburgh, Pennsylvania 15222**. If there are no land use comments received by the end of the comment period, DEP will assume that there are no substantive land use conflicts and proceed with the normal application review process.

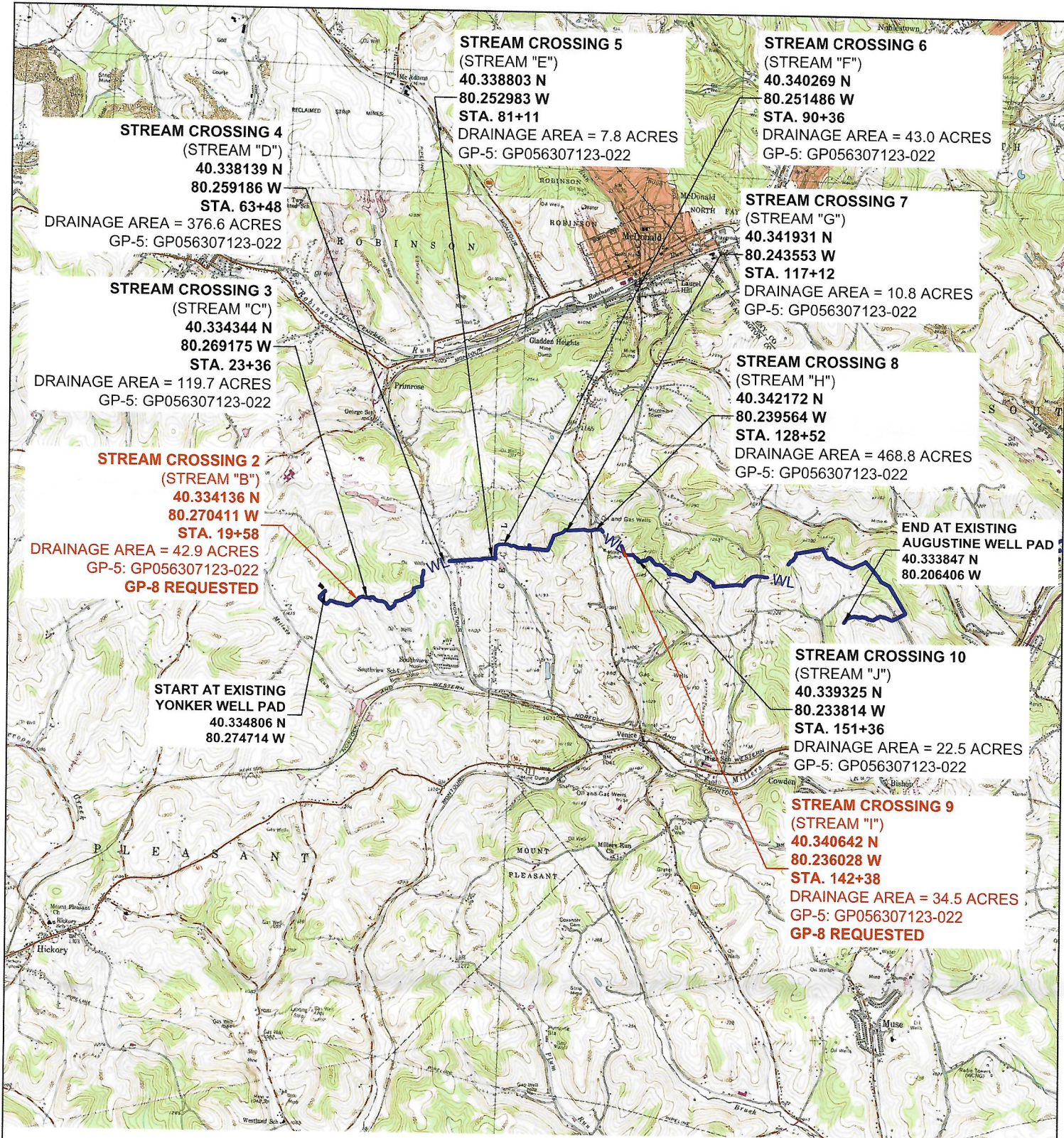

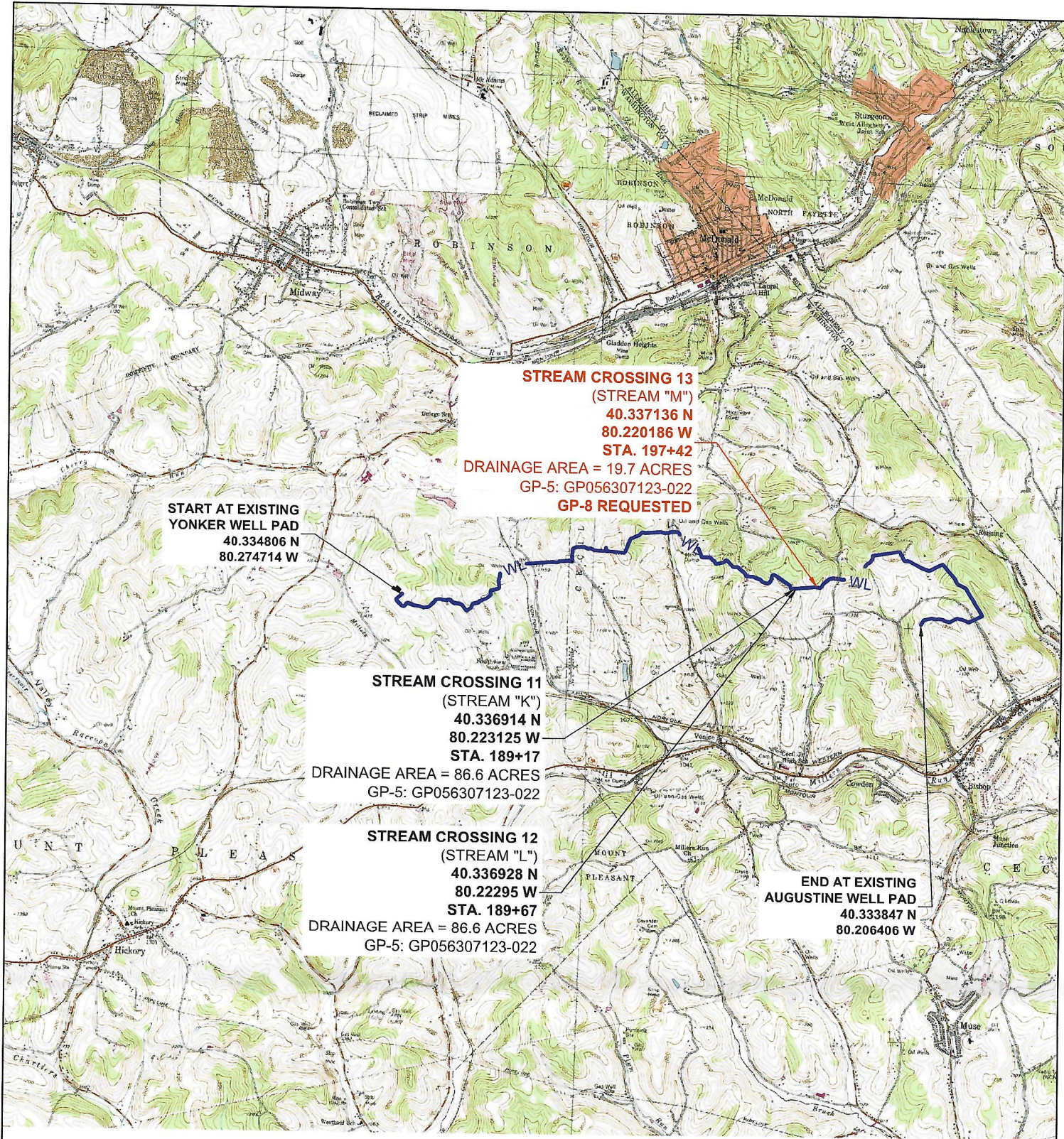
